- It is the responsibility of the homeowner to provide 1-1/2" - 4" below finished grade unless otherwise specified
- All waste and debris will be placed in an on-site container supplied by contractor/homeowner or placed in a neat pile to be removed by homeowner unless specified
- Surfside Pavers, Inc. will not be responsible for any damage to concrete, tile, sod, irrigation, landscaping, rusted culvert pipes or anything not specified in this contract. Concrete tear out based on 4" depth of concrete, additional charge for above 4" thickness.
- Final amounting will be based on actual square footages installed over and above the original contract
- Any permits or bonds will be billed at cost plus 50% administration fee.
- Any charges beyond this contract will be billed for materials and labor plus shipping and/or restocking fees
- It is the responsibility of the Homebuilder / Homeowner to provide proper compacted base.
- Surfside Pavers is not responsible for settlement due to sub base, not compacted properly, especially around culvert pipes.
