  Lake Doctors have been out to treat the water and clean the fountain. They will be back this week to check and continue to monitor the pump and pond.
- 6.) Alpine Tree Service has started trimming and pruning the oak trees in the back of the park. We will be getting a proposal as the trees haven't been trimmed properly in several years and this will be over the amount I am authorized to spend.
- 7.) The ice machine was quarterly serviced per our service agreement, all coils cleaned, ice emptied and inside cleaned.
- 8.) All A/C units (annually) inspected. We will have to replace the outside lobby and library unit in the very near future. This is a budgeted item. Will be getting their report this week.

All applications for the purchase or rental of homes in Holiday Park are carefully reviewed to include checking on Assessment Delinquencies, verification of current authorized pets, shot documentation, and inspection of the homes themselves. If there are any violations, the applicant will not get a decal for their vehicle until the violations are resolved, taxes are paid and all other Holiday Park new resident application criteria is met.

All delinquent assessments are posted in the bulletin board in the club house lobby.

All operators of golf carts in the park MUST be at least 18 years of age.

To date, 179 violation letters have been mailed out to resident. The Trustees have a full status report as well as the office.
