Contractor representative reported that the survey is being done this week and the new home is being manufactured to accommodate current structures and will ensure that they are properly placed.

- Contractor will provide documentation from the City of Palm Bay Building/Permit Department indicating that utility shed's current placement blocking a window is allowed
- If shed is not 6 feet from the property line, it must be moved to comply with Park rules and regulations
- Carport will cover the shed and be attached with straps
- Letter will be produced by District Office indicating the stop work order is rescinded. It will be
 posted on the door and scanned to contractor
