7. Report Daniel Tarnowski the District Manager gave a report. Please make sure all contractors are called in ahead of time to make sure the flow at the gate is smooth. Pool Update On March 1, 2024, the pump on the heated pool went down. Called Eau Gallie they noticed a wire going to the breaker had heated up and melted. Eau Gallie replaced the wire and breaker to meet requirements per specifications. Having a problem with the motor also Eau Gallie doesn't work on motors. Called Pool Doctor they advised the District Manager some company worked on the motor so they would not be able to keep the warranty on it. Called Brevard Pools they came out on March 5, 2024, and stated the motor needed to be replaced. Brevard Pools replaced the motor and a GFCI outlet also had to be replaced for the chemical feeder. Cracks on the bottom of the pool need to be fixed waiting on Pool Doctors on time frame. District Manager would like to charge a fee of 165.00 dollars for 6
